1. Guideline authority

- 1.1. This guideline is issued under section 14(1)(a) of the *Transport Operations (Road Use Management—Vehicle Standards and Safety) Regulation 2010* (the regulation) in accordance with section 22 of the *Statutory Instruments Act 1992.*
- 1.2. This Guideline applies to light vehicles with an *aggregate trailer mass* of 4.5 tonnes or less. This guideline replaces Class Permit No. 051-TH-11 April 2011, from 1 July 2016.
- 1.3. For the replacement guideline/class permit heavy vehicles (vehicles with an *aggregate trailer mass* greater than 4.5 tonnes) contact the National Heavy Vehicle Regulator.

2. Commencement

2.1. This guideline commences on 1 July 2016.

3. Provisions of the regulation that do not apply

3.1. A vehicle operating under this guideline is exempt from complying with sections of the regulation listed in Schedule 1.

4. Application

- 4.1. This guideline applies to the following items which have an *aggregate trailer mass* of 4.5 tonnes or less.
 - Agricultural trailers (load carrying).
 - Agricultural implements (including empty field bins).
 - Trailers loaded with agricultural implements.
 - **Drawn plant** if it is being towed by a conditionally registered vehicle suitably matched to the drawn plant.
 - An *agricultural implement* being towed by a suitably matched *complying vehicle* that is not a conditionally registered vehicle.
 - A trailer if it is being towed by a conditionally registered vehicle with limited access registration in accordance with the conditions of conditional registration.

5. Conditions

- 5.1. While operating under this guideline the following conditions apply:
 - a) Vehicles are to comply with the dimension limits in the regulation or a guideline issued under Section 14(1)(a) of the regulation.
 - b) Trailer or implement must be coupled to the tow vehicle in accordance with Part 12 Section 143 of the regulation.
 - c) Manufacturer's rating for tyres, axles and coupling are not to be exceeded.
 - d) The holder of this permit shall indemnify the Department of Transport and Main Roads and its employees, against any claim, action, or process for damage or injury that may be sustained against them due to the use of vehicles as specified.

Please Note: If the off road operation of a trailer or implement is likely to cause damage to any lamp required by this permit the lamp may be retractable or removable for off road operation. (*For example a removable light board may be fitted to the rear of a plough*)

Schedule 2

For the purpose of this guideline:

aggregate trailer mass — the total mass of the laden trailer when carrying the maximum load recommended by the manufacturer. This will include any mass imposed onto the drawing vehicle when the combination vehicle is resting on a horizontal supporting plane.

agricultural implement means a vehicle without its own motive power, built to perform agricultural tasks, e.g. augers, conveyors, empty field bins, harvester fronts.

agricultural machine means a machine as defined under the *Transport Operations (Road Use Management – Vehicle Registration) Regulation 2010*, Schedule 8.

agricultural trailer (load carrying) means a trailer designed and used to carry agricultural vehicles or equipment that is used to repair agricultural vehicles.

agricultural vehicle means an agricultural implement or an agricultural machine and includes any load (another agricultural vehicle or equipment that is used to repair agricultural vehicles) upon the vehicle.

complying motor vehicle means a vehicle built to comply with the *Transport Operations (Road Use Management - Vehicle Standards and Safety) Regulation 2010* and having current registration for road use.

drawn plant means a machine built on a trailer base, other than an agricultural implement.
